## TRANSPARENCY REPORT Date: June 14th, 2024 - 11:37 PM

on June 14, 2024 we were contacted by Sathia Musso mostly known as "snake" from the username used to found "smutty.com" known for hosting child sexual abuse material, revenge porn, Bestiality and non-consensual porn. Known by some as "the pedophile social network" due to the number of followers and interactions that sexual predators had on the website.

Sathia Francesco Musso contacted us through our <u>contact email with the title</u> smutty.com where he stated that he would take legal action if we did not remove the article from "medium.com" and "osintguardian.com" in addition to removing all posts on the internet related to this. After doing this, he asks us to make a public apology, probably to clean up this person's image.

He told us this as "an opportunity to avoid this consequence" and insulted Claudia Lopez using the words <u>"complete scum"</u>, <u>"awful human being"</u>, he also warned us that by being from Italy and talking about him we supposedly <u>submit to Italian laws</u> and <u>article 595</u> of the Penal Code and then sent us a link to a document from the 2022 edition of the Italian penal code in reference to the crime of defamation.

This person seriously believes that a US citizen and third world people can be persecuted in some way by the Italian penal code. None of the team members are citizens of the European Union, so we cannot be judged in any way by Italian law. That's not how the law works..

Even if the poor accusations of "defamation" were true, that's not how the law works. This demonstrates the lack of professionalism he has to threaten legally and that they are only baseless threats. Wasn't it easier to use chatGPT before making such a mistake?

In the email he also mentioned his family and wanted to take advantage of this to play the victim and use the excuse of "the family" to hide behind them and disassociate himself from the responsibility he has for having founded "smutty.com", without mentioning that Third-party information linked to Francesco was completely in the public domain before, and despite this, we left out a lot of information from them.

It's funny how now Sathia Francesco Musso cares about people's personal data when in "smutty" among the most popular hashtags were <u>#leaks and #leaked</u> in reference to the leaked porn. Not to mention that others, the most popular hashtags were <u>#teen and #young</u>.

The difference between this and us is that all the family information was in the public domain and it wasn't even necessary to use advanced OSINT methods to find it, we also didn't monetize any of our research articles, so we didn't make any money from this. but he probably can't say the same in relation to the Child Sexual Abuse Material (CSAM) and revenge porn.

## response to the email sent by Francesco Musso - snake

The one who responded to the email sent by him was Claudia Lopez, <u>Claudia replied</u> that he was a hypocrite and pointed out several actions carried out by Sathia Musso on his website while using the nickname "snake" and other nicknames while thinking he was anonymous. Now he tries to make another life and wants to disassociate himself from all this, but the past always comes back and this is just karma. Every action has consequences.

<u>It also made him aware</u> of the fact that he is now complaining about the article and making legal threats while thanks to him many children and victims of revenge porn were affected by his horrible website since at some point this horrible person founded it. Simply a scumbag who is capable of threatening an activist against child exploitation and manipulating the situation so that he appears to be the victim.

After these messages he decided to stop sending us messages and never responded to Claudia. We guess what he wanted to gain from this was to scare us into removing the article and any mention of "smutty" and "sathia" on the Internet. which clearly wasn't going to happen. <u>Claudia sent him a message on Telegram</u> and he didn't respond either...
